Pursuant to and in accordance with articles 13 -14 of the EU Regulation 2016/679 relating to 3 of Regulation (EU) 2016/679 (hereafter "GDPR"), concerning the protection of individuals with regard to the processing of personal data and the free circulation of such data repealing Directive 95/46/EC

We would like to inform you that the EU Regulation n.679 of 27th April 2016 on the processing of personal data provides for the protection of individuals with regard to the processing of personal data. Pursuant to and in accordance with article 13 of EU Regulation 2016/679, we kindly ask you to acknowledge the privacy policy and express consent to the processing of data, by signing and returning the attached form.

1. Identification data of the Data Controller (and any other entities)

2. Purpose of the processing

The data is processed only to achieve the purposes related to the First "Gioachino Rossini" Competition for Young Conductors, as necessary to comply with legal obligations and organizational needs. The juridical foundation for the treatment is the participation to the competition and the explicit consent to the way in which the competition is conducted.

3. Method of processing

Personal data will be processed in paper, computerized and telematic form and inserted in the relevant databases that will be accessible to those authorized to process data. The processing of personal data will also be made by third parties that provide specific processing services, administrative services or ancillary services necessary to achieve the purposes listed above. All data processing operations will be carried out in such a way as to ensure the integrity, confidentiality and availability of personal data.

4. Data retention period

The data provided will be kept for the duration needed for the realization of the Competition with all the related organizational needs.

5. Scope of communication and dissemination of data

In relation to the purposes indicated in p. 2, the data may be disclosed to the following third parties:

- event management and communication companies, online and offline;
- banking institutions for the management of receipts/collections and payments;
- financial administrations or public bodies in fulfilment of regulatory obligations;
- companies and law firms for the protection of contractual rights;
- firms of certified accountants for tax purposes.

Photos submitted by the participants and videos made during the Competition may be published on the web, on social media channels or on the FGR website or used for communication activities related to the Competition. The e-mail addresses provided will be exclusively used to send communications related to the Competition.





6. Rights under art. 15, 16, 17 18, 20, 21 and 22 of EU REG. 2016/679

We inform you that as the interested party, besides the right to lodge a complaint with the Supervisory Authority, you also have the rights listed below, which you can exercise by submitting a specific request to the Data Controller, as indicated in p.1.

<u>Art. 15 - Right of access</u> - The data subject shall have the right to obtain from the controller confirmation as to whether or not personal data concerning him or her are being processed, and, where that is the case, access to the personal data concerning the treatment

<u>Art. 16 - Right to rectification</u> - The data subject shall have the right to obtain from the controller without undue delay the rectification of inaccurate personal data concerning him or her. Taking into account the purposes of the processing, the data subject shall have the right to have incomplete personal data completed, including by means of providing a supplementary statement.

<u>Art. 17 - Right to erasure (right to be forgotten)</u> - The data subject shall have the right to obtain from the controller the erasure of personal data concerning him or her without undue delay and the controller shall have the obligation to erase personal data without undue delay where one of the following grounds applies:

- a. the personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed;
- b. the data subject withdraws consent on which the processing is based according to point (a) of Article 6, or point (a) of Article 9, and where there is no other legal ground for the processing;
- c. the data subject objects to the processing pursuant to Article 21 and there are no overriding legitimate grounds for the processing, or the data subject objects to the processing pursuant to Article 21;
- d. the personal data have been unlawfully processed;
- e. the personal data have to be erased for compliance with a legal obligation in Union or Member State law to which the controller is subject;
- f. the personal data have been collected in relation to the offer of information society services referred to in Article
 8.

<u>Art. 18 - Right to restriction of processing</u> - The data subject shall have the right to obtain from the controller restriction of processing where one of the following applies:

- a. the accuracy of the personal data is contested by the data subject, for a period enabling the controller to verify the accuracy of the personal data;
- b. the processing is unlawful and the data subject opposes the erasure of the personal data and requests the restriction of their use instead;
- c. the controller no longer needs the personal data for the purposes of the processing, but they are required by the data subject for the establishment, exercise or defence of legal claims;
- d. the data subject has objected to processing pursuant to Article 21 pending the verification whether the legitimate grounds of the controller override those of the data subject

<u>Art. 20 - Right to data portability</u> - The data subject shall have the right to receive the personal data concerning him or her, which he or she has provided to a controller, in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller without hindrance from the controller to which the personal data have been provided.

In exercising his or her right to data portability pursuant to paragraph 1, the data subject shall have the right to have the personal data transmitted directly from one controller to another, where technically feasible

<u>Art. 21 – Right to object</u> - The data subject shall have the right to object, on grounds relating to his or her particular situation, at any time to processing of personal data concerning him or her which is based on point (e) or (f) of Article 6, including profiling based on those provisions.





<u>Art. 22 – Rights in relation to automated decision making process and profiling</u> - The data subject shall have the right not to be subject to a decision based solely on automated processing, including profiling, which produces legal effects concerning him or her or similarly significantly affects him or her.
